### Fields A & B – Two Fields will be used for Senior and Master Hunter 30-minute Stakes

Fees for entries and camping include a Processing Fee. Entries and camping may be cancelled or changed online prior to close of entry, with refunds (less the Processing Fee per entry and per camping item) available to keep as PerfDog credit, refund to credit card, or mail via check (less a \$3 Check Fee). Entries and camping may be cancelled online after close of entry, but no refunds will be given.

### Courses and Birds

All tests will be run on a single course with bird field. Native and/or released quail will be used in all tests. Blank cartridges will be fired in the Junior Hunting Test if bird contact is made. Only blank guns with closed barrels up to .32 caliber are permitted. All live shooting will be done by official gunners for Master and Senior Hunting Tests. Galleries must remain behind judges at all times. Use of AKC approved tracking collars/GPS devices is permitted but not provided.

Junior Handlers (under 18) are welcome in all tests for a \$10 reduction in entry fee per test. Please let the Event Secretary know in advance. Junior Handler forms will be available. *"For online entries, include 'I'm a junior handler' in the notes field when you enter. You will receive a refund for the amount of your junior handler discount after entries close and the secretary confirms your junior status."*
